and habits are replaced, we may be able to abandon the formatity of our arrangement, but now the formatity is imperative. Good intentions are simply not enough.

Our agreement is designed for our particular situation only in which my bushand works all day at a job of his choice, and I work at home on a free-lance basis during the hours the children are in exholo (from 8:30 till 3:00). If my husband or I should change jobs, income, or working hours, we would probably have to adjust our agreement to the altered circumstances. Now, as my husband makes much more money than I do, he pays for most of our expenses.

Marriage Agreement I. Principles

We reject the notion that the work which brings in more money is the more valuable. The ability to earn more money is altered by a privilege which must not be compounded by enabling the larger earner to buy out of higher duties and put the burden on the one who earns less, or on someone hired from outside.

We believe that each member of the family has an equal right to histher own time, work, value, choices.
